- (b) You are responsible for maintaining the confidentiality of your account and password, and for restricting access to your account. You agree to accept responsibility for all activities that occur under your account.

(ii) When you invest or withdraw, an additional currency conversion is processed, thus, taking an additional 1 week before capital is actually invested, or withdrawn. (iii) Thus, you can expect your capital to be invested after 1 week of the investment/withdrawal period, or at least a week till capital is withdrawn from the fund.
- (d) Once capital is withdrawn, profits will be calculated and distributed to investors (usually taking 1-2 weeks, or more depending on the payment system), this may involve fees depending on the investor's original payment method.

- (a) You acknowledge that you may lose your money when depositing, investing, or withdrawing money. This includes payment fees, currency conversion, and investment. You acknowledge the risk of investing that you may lose all your investment. This includes several losses and the possibility of losing all capital.
